Each nomination for a position on the Executive Committee **must be supported by two current SAM members** (a proposer and a seconder). **Any form that does not have the membership details of two current SAM members will not be accepted. The nominee must be informed of and accept the nomination. Signatures of the proposer, seconder, and nominee must all be included in the form.** The list of the 2024-2026 SAM Executive Committee is attached for your reference.

3. Please note that all members of the Executive Committee must be a member of SAM, as at the commencement of the AGM.

- (i) **Only Singapore citizens may be nominated** for Position 1 – President
- (ii) **Only Singapore Citizens or Singapore Permanent Residents** may be nominated for Positions 2 to 8.
- (iii) Where there is no Singapore Citizen or Singapore Permanent Resident nominated for Positions 5 to 8, the newly-elected President may co-opt a member who has a close connection with Singapore or the Singapore Community in Myanmar to take up Positions 5 to 8.
